## 4. FIRST AID MEASURES

### Description of necessary measures

**Inhalation:** First aid measures not required.

### Most important symptoms and effects, both acute and delayed

After eye contact: May cause mild to severe irritation with possibility of permanent eye damage. After skin contact: Repeated or prolonged excessive exposure may cause irritation or dermatitis. After inhalation: Unlikely to occur due to the physical properties of the product. At elevated temperatures, vapors or mists may cause irritation. After ingestion: Ingestion may cause irritation of mouth, throat, digestive tract, diarrhea and vomiting.

### Indication of any immediate medical attention and special treatment needed
